Application Requirements:

- A resume that highlights their interest in service and activism by presenting relevant academic, professional, and volunteer experiences
- A 500-word statement responding to the following question:
 - With so many people and organization in today's world in need of volunteers and financial assistance, how should people decide where to direct their time and donations?
- Applicants must also submit a current academic transcript from the applicant's school, or an
 academic transcript of the applicant's most recent school (including the applicant's most recent
 year in school).
